1. **The Minutes of the last meeting held on 27th September 2006** were confirmed as a correct record and signed by the Chairperson.

2. **Matters arising from the Minutes**

ACRE Rural Housing Enabler. Pam Evans and Keith Mobbs will met with Laura Razzell, Rural Housing Enabler and a representative from Hastoe Housing Association on 28th September, they were happy to progress with the Lofts site to the left of the church. There will not be any money available for two years but we should get about twelve affordable homes there when it is.

Lorry Count. The clerk contacted Joe Aley, Area Bridge Engineer to ask for a proper assessment of the railway bridge. He confirmed that the bridge was assessed at a 25 tonnes limit in 2001. A full engineering assessment has still to be carried out. Barclay Dutson has had a look at Cambs CC online route mapping site, his view is that it needs improvement as it is not user friendly and truck drivers would not use it.

Churchyard wall repairs. John Abbott chased up ECDC for the payment of the grant, it is expected next week.

Memorial stones. The clerk completed the application form to obtain a grant of 40% towards the cost of the repairs. Michael Allan spoke with ECDC, we could apply for 50% but it would have to go before a committee, whereas we would be able to have the 40% immediately. The Parish Council decided, that we would opt for the 40% now.

Street Lighting. The faults on the flashing traffics signs have still not been repaired.

RAD Warehousing Mercury lighting. No news.

Village tidiness. We are still waiting for the quotes for the repair of both notice boards. After further investigation it appears that the van is parked illegally on the grass verge opposite 36 Station Road, the clerk will report this. The clerk is to contact David Groom at the Highways Dept concerning the encroachment of the grass verge onto the pathway in Station Road.

Jointly Funded Minor Highways. No news.

The Carrops, Red Lodge Barclay Dutson reported that 600tons of waste had been delivered there and there were very bad smells emitting from there. John Abbott and Barclay Dutson will both report it to the Environmental Health at ECDC.

Wildtracks. Pam Evans went to the pre inquiry meeting. The noise and drainage experts from both sides have to come to a mutual agreement before the inquiry. It is not hopeful that the Wildtracks Action Committee will win. The Parish Council will discuss this further before the inquiry. Barclay Dutson reported that the week before there had been very bad noise emitting from the site.

Cambs ACRE, Annual Review. They can help advise on community funding, this may be useful to The Kentford & Kennett Village Hall & Maclaren Playing Field Association. They can also assist with funding for Parish Plans. We will have to survey the village community to ask for their opinions and ideas. A committee will have to be formed to carry this through.

ECDC, E C Economic Development Strategy 2006 – 2011. It is expected that there will be 17% population growth between 2001 – 2021, and 49% of employed will commute out of the district.

Neighbourhood Panels. Pam Evans attended an introductory meeting with representatives from ECDC and the Police. Barclay Dutson will attend the next meeting at Soham Pavilion on 15th November.

ECDC, Sports Facilities, Play Areas and Informal Open Spaces. The clerk wrote and informed them that we have a full size football pitch to league standard.

3. Police and Community

East Cambs Neighbourhood News, Crime reports for October. Local Police Surgeries for October, November and December.

The crimes reported during September and October were, an office in Station Road was broken into, nothing taken only damage to the door, a tractor and trailer were stolen from Kennett Cottages, a car was broken into and the stereo was stolen on Dane Hill Road.
